Data Controller and Owner Types of Data read / collected

Among the types of Personal Data that this Application collects, by itself or through third parties, there are: cookies, usage data and geographic position. Application also reads phone line state and have access to public data stored on external storage (read / write access)

The Personal Data may be freely provided by the User, or collected automatically when using this Application.

Any use of Cookies - or of other tracking tools - by this Application or by the owners of third party services used by this Application, unless stated otherwise, serves to identify Users and remember their preferences, for the sole purpose of providing the service required by the User.

Mode and place of processing the Data

Methods of processing

The Data Controller processes the Data of Users in a proper manner and shall take appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. Phone (This Application)

This Application has read only access to phone line state, including status of any ongoing and incoming calls.

Personal Data read: phone line state.

Why: to handle proper behavior of This Application during incoming / outgoing call.

Disk access

External storage (This Application)

Allows This Application to read and write from / to external storage.

Personal Data read: data stored on external storage mounted into the phone.

Why: to store / read on / from external storage This Application data and configuration.

Additional information about Data collection and processing

Legal action

The User's Personal Data may be used for legal purposes by the Data Controller, in Court or in the stages leading to possible legal action arising from improper use of this Application or the related services.

The User declares to be aware that the Data Controller may be required to reveal personal data upon request of public authorities.

System logs and maintenance
